This project allowed us to think, in a personal and collective manner, how nature and landscape can be approached and filmed as subjects. It has also let us initiate a fertile conversation between the legal and the filmic concept of **nature as subject** and to translate a legal notion into a film gesture. We have also learned how the symbolic scope of a judicial decision can stimulate the artistic community and its inspiration. Art can be a source both of recognition and change.

The result of the project; 5 short documentaries, not only positioned the Atrato river; its beauty and its drama in the spotlight, but also gave us the great evidence of the richness of collective creative process.

Were these outcomes as expected? Yes, actually we believe that these outcomes even exceed our expectations. We weren't anticipating the fertility of the deliberation both in the early stages, among us, and during the final presentation with the public. We are also amazed by the aesthetic quality of the films and the way 5 shorts generate a solid single piece.

In what ways were the project and its results important given current developments (social, economic, political) in its context? This project allows us to raise consciousness about the different kinds of impact a judicial decision can have. On civil society, and specially on the artistic community, it has opened a vivid exchange not only about the ecological problems of the region, but specially, about the different possible ways to address and communicate them. This region needs attention, reflection and support, our project offered attention and reflection. Hopefully, in the next stage of dissemination, we will be able to contribute to the awareness about the importance of a persistent and effective economic support. We believe that politics is essential and this type of initiatives and results can generate a larger political awareness, both at the local and national levels.

Target group

Did you reach the intended target group (as participants or audience)? Has the project benefitted underrepresented groups within your context (on the basis of their age, gender, sexuality, disability, race, ethnicity, religion or economic or other status)? And if so in what way?

We received 15 submissions and selected 6 directors, two of them co-directed. 4 of the 6 directors are women. One of them is gay. From the gender and sexuality point of view we reached this targeted group fully.

Notwithstanding, we had trouble reaching one intended group: the African Colombian directors from the Atrato region. Even though we received two proposals from Choco, and we selected one of them, the recipient left the group just before we began our editing workshop. We had the same difficulty when we tried to invite one of the *Guardianes* to the presentation in Medellin. Maybe due to the current security issues in the region--the very same that prevent us to travel to Choco—they weren't able to attend any stage of the project.

Differences with the original Budget and changes in activities:

In the midst of the pre-production's inquires and procedures, we have been told that very serious security problems are taking place in the region. We then decided to change the 5-day shooting activity and transformed it in a 5-days editing workshop. The budget for this activity was the same.

We are going to present the films in Bogota in collaboration with the Goethe Institute, this activity wasn't considered in the original budget. We hope to have the chance of presenting the final product in different scenarios and countries.

If colleagues of yours undertake a similar project, what would you, based on your recent experience with this project, recommend them to do (or advise not to do)? Please give 3 concrete short pieces of advice.

Our main concern in this process has been the difficulties we confronted to integrate the community we were going to address. We truly wanted to have the irreplaceable approach only a local filmmaker could provide, yet we couldn't. Our recommendation will be to secure local help in order to assure the active participation of the artistic local community.

It would also had been better if we had considered the process of dissemination to take place during the period of the grant. This is the best way to assess the potential of any initiative.

We believe that the most important part of this project was the plural and multidisciplinary approach, it is our recommendation then to consider as many disciplines as possible and feasible.

Feedback for us-we're open for evaluation too.
